- After the conference, authors should submit the paper presented at the IECS via Easy Chair system, no later than **June 26, 2021**. Papers written in English should be of 6-14 pages long and must comply with the guidelines described in the IECS 2021 Template.
- Participants can send up to two papers as a single author or in collaboration.
