- After the conference, authors should submit the paper presented at the IECS via EasyChair system, no later than **November 15, 2020**. Papers written in English should be of 6-12 pages long and must comply with the guidelines described in the IECS 2020 *Template*.
- Participants can send up to two papers as a single author or in collaboration.
